POLICY OF THE COLLEGE ON STUDENT GRIEVANCES, HARASSMENT AND RAGGING

The college closely follows the regulations published by UGC time to time. In consonance with the UGC regulations of 2009 regarding ragging the college maintains the policy of keeping the campus ragging free. The college is committed to maintaining an environment that encourages and fosters appropriate conduct among all persons and respect for individual values. The institution makes it a point that none of its stakeholders undergoes any sort of harassment. Thus it enforces Anti-Harassment Policy and Complaint Procedures at all levels in order to create an environment free from discrimination, harassment, retaliation and/or sexual assault.

COLLEGE LEVEL MECHANISM FOR HANDLING STUDENT GRIEVANCE INCLUDING SEXUAL HARASSMENT AND RAGGING

Strict directions are given to the students and the parents during the time admission about the code of conduct and the rules, the students should be adhered within the campus. Written assurances or affidavit are collected from both the student and the parent. The important steps taken by the college to maintain a ragging free and harassment free campus and to maintain strict discipline in the campus and also to address the complaints, the following mechanism was implemented by the authorities.

- 1. Awareness programmes such as classes, notices, public announcements etc.
- 2. Affidavit signed by the students and the parents at the time of admission.
- 3. Common address by the Principal and teachers in charge of various committees and cells such as Anti-ragging Committee, Women's Forum, Anti Harassment Committee etc at the time of admission, especially on the opening day.
- 4. Classes by Police officials and other law enforcing authorities.
- 5. Complaint boxes kept in front of the office.
- 6. Various committees handling the complaints.
- 7. Enquiry committees constituted by the Principal in consultation with the College council.
- 8. The Principal is authorised to take stringent action including suspension, dismissal etc if a person is found guilty.
- 9. Reporting the incidents to Police.




